Vice President Mark Benson called the May 2011 meeting to order at 7:04pm. A pledge of the flag, a moment of silence, and roll call were all completed. Tom Gullo makes a motion to accept the minutes from April. Tim Boel seconds the motion and report is accepted by the membership.

REPORT OF THE FINANCIAL SECRETARY

Financial Secretary N. Baker reports 41 checks were written during the month of April. Six (6) checks were written for over \$500.00. Bob Falls Sr. makes a motion to accept the report, David A. Cook seconds the motion and the motion is carried.

MONTLY VISA BILL REPORT

Vice President Mark Benson reports the previous balance of \$704.42 was paid in full and received by Chase on April 12th. The new balance is \$4,702.85. There was one purchase that was made for over \$200.00 which was the bill for the fire alarm system. The cost was \$3,778.00 to Simplex Grinnell. Bob Reineke makes a motion to accept the report, Ed McCabe seconds the motion, and the motion is carried.

REPORT OF THE TREASURER

Treasurer Paul Benson reports the total income for the month of April is \$19,138.18. The total expenses were \$26,904.05. Our total assets equal \$256,291.99. Mike Memole makes

a motion to accept the report. Bob Falls Sr. seconds the motion and the report is accepted by the membership.

REPORT OF THE OFFICERS

District Chief Ed Di'Martino reports Lebannon Valley Speedway is hosting a public safety night on June 11th. Chief Di'Martino presented certificates to Captains Mike Benson Jr. and Jeff Tooker for completing the COLT training (leadership conference) in Buffalo back on April 1st. The town Memorial Day parade is May 28th and step off is at 10:00am. The parade route will be from Spare Time to the American Legion. The Red Caps band is booked for this parade. Engine 9 will be going to Lake George for the HVVFA convention. The mock DWI crash will be on June 3rd at Columbia High School. All SCBA's were hydro-tested. All the hose was also tested. The station generators are in good shape. All of the trucks will be having annual maintenance completed soon.

Dave Cook inquires about the payments for the janitors, and what we will be doing to make up for the lost income with the Church leaving. Tim Boel elaborates further reporting the financial loss with the church taking their services elsewhere is \$9,000.00. President Tooker will follow up at next month's meeting.

RP Smith reports that 3 weeks ago on a Sunday afternoon the lights were on at 2:30pm in the afternoon. Whoever turns them on has to set a timer. Ricky and Tim Boel explain where in the mechanical room the setting is for the lights. Tim Boel mentions to the members that if you see the lights on that particular day turn them off, don't wait until the company meeting to talk about it.

Building Manager Mike Stafford reports that the lady that did the kickboxing last year in the parking lot wants to do the same thing as last year. Mike reports this will be an extra \$3,000.00 for using the parking lot at HQ for 1 hour.
