

East Greenbush Fire Company Annual Meeting / Election of Officers December 19, 2017

The Annual Meeting / Election of Officers was called to order at 7:15 pm by President Lansing, in the Banquet Hall.

Rich Hendrick (Sgt at Arms) led us in the Pledge of Allegiance, and a moment of silence was observed for our departed members.

The motion carries.

President Lansing reports that the cleaning quotes and the heater at the North will be discussed in further detail at the January 2018 Company meeting.

New Business

President Lansing reports that the Snowplowing Bid at the Park Station was awarded by the Executive Board to Chris Lavin for 2018 in the amount of \$3,500.

Anthony Gullo requests that his name be stricken from the ballot.

Vice President Iorio authorizes the ballots to be distributed.

Voting commenced.

A motion was made by Greg Forgea, seconded by Joe Winnicki, to close balloting.

The motion carries.

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Tracy Cullum was elected Vice President for 2018.

Vice President Iorio reads the names of the members running for Recording Secretary – Gina Pendolino, Chuck Rossbach, and Jeff Tooker.

Jeff Tooker requests that his name be stricken from the ballot.

Vice President Iorio authorizes the ballots to be distributed.

Voting commenced.

A motion was made by Chuck Alger, seconded by Matt Wasileski, to close balloting.

The motion carries.

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Gina Pendolino was elected Recording Secretary for 2018.

Vice President Iorio reads the names of the members running for Sergeant-at-Arms –

Christie Cullum, Rich Hendrick, Dan Reyner, and Matt Wasileski.

No candidate wished to withdraw their name.

Vice President Iorio authorizes the ballots to be distributed.

Voting commenced.

A motion was made by Tim Boel, seconded by Nick Field, to close balloting.

The motion carries

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Christie Cullum was elected Sergeant-at-Arms for 2018.

Vice President Iorio reads the names of the members running for Board of Directors positions – Mike Benson, Jr., Thomas Chesser, Nick Madore, Rich Hendrick, Dan Reyner, Chuck Rossbach, and Jeff Wasileski.

Election Chair Pete Lehmann explains that we will be voting for three (3) candidates – the top two vote-getters will be awarded three-year terms (2018-2020) and the third top vote-getter will take Tracy Cullum's vacated spot for 2018 and 2019.

RP Smith arises and raises a concern over an Assistant Chief running for a Board of Directors spot and the potential conflict of interest.

Tom Chesser raises a similar concern.

Mike Benson, Sr., states that, in his opinion, a candidate can be entrusted to abstain from votes when needed.

Vice President Iorio inquires with Tom Chesser as to this conflict being specifically spelled out in our By-Laws.

Tom Chesser replies that there is nothing in the by-laws.

Vice President Iorio authorizes the vote to commence.

Dan Reyner requests that his name be stricken from the ballot.

Voting commenced.

A motion was made by Lou Roher, seconded by Luke Palmer, to close balloting.

The motion carries.

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Mike Benson, Jr. and Jeff Wasileski have been elected to the two three-year terms, and Tom Chesser has been elected to the two-year term.

Vice President Iorio reads Article 5, Section 2, Paragraph 3 of the By-Laws with regards to voting for Captain, Lieutenant, and Foreman and reminds those who are ineligible that they cannot vote.

Vice President Iorio reads the names of the members running for Captain -

Mark Becker, Anthony Gullo, Mike Lansing, Nick Liuzzi, Nick Madore, Luke Palmer, and Nick Field.

Rick Williams inquired with Luke Palmer as to his plans in 2018.

Luke Palmer stated he will be in town through March 2018.

No candidate wished to withdraw their name.

Vice President Iorio authorizes the ballots to be distributed.

Voting commenced.

A motion was made by Kurt Schlachter, seconded by Jim Alcombright, to close balloting.

The motion carries.

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Mark Becker, Anthony Gullo, Mike Lansing, Nick Liuzzi, and Nick Field have been elected Captains for 2018.

Vice President Iorio reads the names of the members running for Lieutenant –

Glen Cook, Todd Cullum, Nick Field, Anthony Gullo, Jake Hallenbeck, Nick Madore, Taj Plante, and Dan Reyner.

Vice President Iorio states that Nick Field and Anthony Gullo are stricken from the ballot, as they were just elected Captain.

Vice President Iorio states that Taj Plante is stricken from the ballot, as he does not meet the requirements (two years of active service) for Lieutenant.

This leaves five candidates for five positions.

A motion was made by RP Smith, seconded by Tom Whittemore, to have the Secretary cast one ballot in the affirmative for Glen Cook, Todd Cullum, Jake Hallenbeck, Nick Madore, and Dan Reyner.

The motion carries.

Vice President Iorio states that Glen Cook, Todd Cullum, Jake Hallenbeck, Nick Madore, and Dan Reyner have been elected Lieutenants for 2018.

Vice President Iorio reads the names of the members running for Foreman –

Nick Field, Rich Hendrick, Nick Madore, Dan Reyner, Chuck Rossbach, Carl Schilling, RP Smith, Mike Prestipino, Matt Wasileski, and Joe Winnicki.

Vice President Jorio states that Nick Field is stricken from the ballot, as he was elected Captain.

Vice President Iorio states that Nick Madore and Dan Reyner are stricken from the ballot, as they were just elected Lieutenants.

Chuck Rossbach requests that his name be stricken from the ballot.

Voting commenced.

A motion was made by Tom Chesser, seconded by Todd Cullum, to close balloting.

The motion carries.

Votes were tabulated in the Coat Room at the Banquet Hall.

Election Chair Pete Lehmann states that Rich Hendrick, RP Smith, Mike Prestipino,

Matt Wasileski, and Joe Winnicki were elected Foreman for 2018.

Vice President Iorio states that there is one candidate for Fire Police Captain – Tom Whittemore. He also states that there are three candidates for Fire Police Lieutenants – Joe Lacivita, Marty Miller, and Nelson Williams.

This is an uncontested race.

A motion is made by Tom Chesser, seconded by Jeff Wasileski, to have the Secretary cast one ballot in the affirmative for these candidates.

The motion carries.

Good of the Order

Mike Benson, Jr. thanks Jeff Tooker and the crew for a great Christmas party.

George Forgea reminds people to see him tonight for the life insurance paperwork.

Bob Lehmann states that new apparel will be ordered and paperwork will be out shortly.

Vice President Iorio makes a motion, seconded by Pete Lehmann, to name Chuck Hellmuth as the Delegate to the HVVFA Convention in 2018 with Tim Boel as the Alternate. The motion carries.

Nick Madore makes a motion, seconded by Luke Palmer, to name Greg Forgea as the Delegate to the HVVFA Convention in 2018 with Mike Benson, Jr. as the Alternate. The motion carries.

President Lansing gives brief remarks on the positive contributions our members made in 2017.

Tonight's 50/50 is \$117. RP Smith is the winner.

A motion was made by Elwin Michel, seconded by Chuck Alger, to adjourn the meeting. The motion carries.

The meeting is adjourned at 9:30 pm.
